Capital Projects Update

St. Patrick Modernization

We are still trying to organize a meeting with Alberta Education to determine the full scope of work, timelines and delivery method.

St. Marguerite Bourgeoys School

Work is complete on the portion of St. Marguerite but the fire alarm safety devices are unable to be verified until the entire scope of work is complete. This means that we will not be able to move into these spaces until the end of June.

St. Gregory the Great Catholic School

Substantial completion of the school was achieved on June 1. There are a few outstanding items that are being cleaned up and furniture orders have begun to arrive.

Our Lady of the Rosary Modular relocation

Timcon Construction has been awarded this contract and are working with the Town of Sylvan Lake to get final approval of the building permit. As a result of this delay the addition will not be ready for occupancy until early October.

St. Elizabeth Seton Modular relocation

Tenders closed on this project and the contract has been awarded to Pearl Rose Construction.

Fr. Henri Voisin Modular addition

ABC School has indicated that construction will begin in June in preparation of the modulars arriving at the end of June.
