5. DISCUSSION ITEMS

- 5.1 ADMINISTRATIVE PROCEDURE 458 DUTY TO REPORT
 Secretary-Treasurer Latka presented the Administrative Procedure 458 Duty to
 Report and informed Trustees that the procedure was communicated with all
 schools and facilities within the Division.
- 5.2 TRUSTEE REMUNERATION REVIEW
 Secretary-Treasurer Latka presented the Board of Trustees with the Trustee

Remuneration Review Report and highlighted that as per Policy 19 - Board Operations, the Trustee rates of remuneration shall be adjusted annually in September to reflect the change in the Alberta Consumer Price Index (CPI). Latka recommended that based on the information presented, an adjustment to the Trustee remuneration be an increase of 1.90% based on the CPI increase for the period July 1, 20222 through June 30, 2023.

Trustee Watson agreed that the Board should adhere to the referenced policy and accept Latka's recommendation. As the recommendation falls within policy, there is no requirement for a motion for the recommendation.

5.3 BOARD MINI RETREATS DATES FOR CONSIDERATION

Superintendent Finnigan presented Trustees with potential dates to hold additional full-day Board miini-retreats for the 2023-2024 school year. The following dates were set for holding full-day board mini retreats for the 2023-2024 school year:

5.5 JOINT MEETING WITH THE CITY OF RED DEER

The Superintendent informed Trustees about a joint meeting with the City of Red Deer on November 7, 2023 and requested feedback for potential discussion items. A variety of potential topics were discussed including future land

availability for Catholic schools, improved accessibility to recreational facilities, youth and training programs, more frequent review of City transit contracts, safety concerns at the Collicutt Centre, and the potential for recreation facilities to support structured programming. The Board of Trustees is also interested in a GH Dawe Community Centre presentation and how the facility could be utilized by Division schools.

5.6 2024-2025 CALENDAR COMMITTEE

Associate Superintendent Ledene presented the 2024-2025 Calendar Committee Report and explained that they are in need of one Trustee to become a representative on the committee. Vice-Chair Lonsdale put her name forward for the committee.

6.1 SUPERINTENDENT REPORT

Superintendent Finnigan presented the Superintendent report giving Trustees an update on the first Faith Formation evening for new probationary contract teachers. The Associate Superintendent of Curriculum provided Trustees with an update on the new curriculum implementation and shared that Administration met with Red Deer Polytechnic President and Vice President, Academic & Student Experience at the Confluence Campus in Rocky Mountain House to assess community needs and discuss future partnerships particularly focusing on dual-credit programs and work-integrated learning opportunities for student within the school division.

6.2 SECRETARY TREASURER REPORT

Secretary-Treasurer Latka presented the Secretary Treasurer report as information and highlighted the financials for the St. Lorenzo Ruiz Middle School project, and the upcoming grand opening event.

6.3 SCHOOL BUS ADVANCE FUNDING PROGRAM

Secretary-Treasurer Latka informed Trustees of new funding that is now available to school boards that manage their own student transportation fleets. Latka stated that due to budget changes for the 2023-2024 year, the Division will require 10-15 additional buses and is currently working on finalizing the number of buses required prior to submitting an application for the school bus advance funding program.
